## **Pantomime**



Parents of children in Year 1 and Year 2: you will receive a letter this week with details of the pantomime trip which has been organised for December. This is a very popular trip with the children. Please note that whilst the contribution that we ask for is voluntary, we heavily subsidise the trip with fundraising events throughout the year. Unfortunately, we are only able to run the trip if sufficient contributions are made.

Parents of children in Early Years (2 year olds, Nursery and Reception), we are hoping for the children to have a theatre performance in school, and will in touch with further information in the coming weeks.

# **Traffic around School**

As you are aware, there are ongoing challenges with parking and traffic around the school. We are working with the local councillor, Jackie Ramsay, to look for ways that we can keep the school site safe and accessible.

Please do walk to school if at all possible, to reduce the number of cars around the school site. Do not park on the zig zag markings, or bloke driveways. We will keep you updated with any further plans to improve the situation.

# **Nursery Places**

If you or any friends or family have a child who would like a place in our 2 year old or 3 year old nurseries from January or April, please pop in to collect a form from the office.

## **Free School Meals**

Your child may be eligible for Free School meals and the holiday food vouchers that have been provided each holiday so far, if you are in receipt of any of the following;

• Income Support

- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

You need to apply online with the DFE 'applying for free school meals'.

Each child who is in receipt of this funding means that school receives £1,385. This means we can buy more resources, provide additional support in classes and have outside providers come into school to support your child's learning.
